Hazards Identification

Not classified as a hazardous material.

First Aid Measures

Inhalation: No vapours present at normal temperatures.

Storage: in a cool dry room avoiding exposure to light. Keep away from possible sources of combustion.
Optimum storage temps: 10-22 deg C. Store in tightly sealed containers.
